

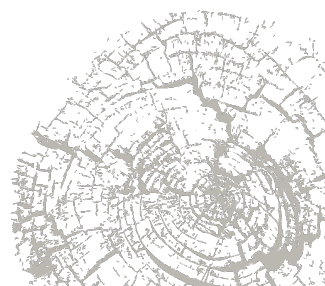

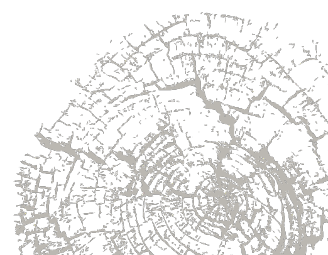
With a focus on innovative practice and new ideas, the conference will have something for everyone, including:

AWS 2022 is proudly presented by:

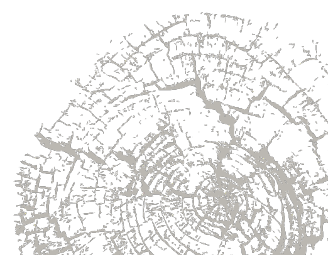


There's something for everyone – our 2022 streams

We welcome abstract submissions from people who:

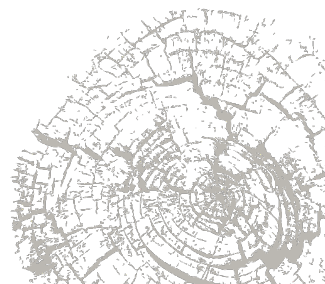
- are involved in delivering innovative evidence-based AOD programs and services

Criteria

All submissions will be reviewed against the following criteria:

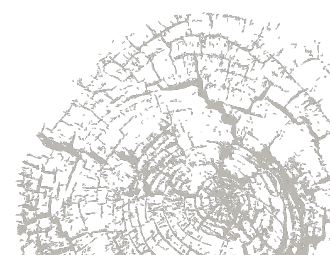
- Audience – relevance to AWS2022 audience
- Themes – relevance to the AWS2022 overarching theme and topics
- Quality – appropriate educational, evaluation, or research methodology and clarity
- Content – presenting new work or building upon existing work (new news; not old).

General guidelines

The following points should be noted:

- Abstracts will be subject to peer review
- Acceptance or otherwise is at the discretion of the organising committee whose decision is final
- Refer to the template on the conference webpage for the abstract layout
- All presenting authors must register and pay to attend the AWS2022 conference to be eligible to present. We are unable to advertise speakers in the conference program until they have registered and paid in full
- Submission of an abstract implies the author's agreement to publish their abstract in the final conference program handbook
- Successful abstracts must be presented by the author/s or a nominated co-author.
- The AWS2022 Organising Committee reserves the right to reject abstracts which do not include sufficient information.



Increasing the voice of lived experience

We want to increase the representation of speakers with a lived experience of AOD use in the AWS2022 program.

If you are - or know - someone who is either in AOD treatment, has completed treatment, is a parent, carer, or family member of someone who uses substances or has some other unique perspective on AOD, then we want to hear from you!

We understand that speaking about substance use at a conference may be daunting. We also understand that there are potential risks with disclosing substance use in public. However we are also aware of the benefits – both personally and professionally – to using the power of lived experience in helping others to learn, understand, and make change.

That's why the AWS2022 Committee is offering to provide personalised assistance to individuals with a lived experience to support them to be involved. A representative from our committee will become a fixed contact point for you, assist you in preparing your abstract, discuss any questions or concerns you may have and, if your abstract is accepted, assist with reviewing your speech or presentation, including by connecting you with local support workers. We can also support you to share your story or perspective in a way that maintains your privacy and anonymity.

We want to make this the best and safest experience for you.
